If payment has not been received by the 5th of the month, card key will be de-activated. A \$15 fee will be charged to re-activate card key. Additionally, you will be required to pay the posted hourly parking rate for each day that your card is de-activated.</p> <p>Pro Rated: Monthly parking will be prorated in half month intervals.</p> <p>Refunds/Credits: Accounts cancelled prior to the 15th will receive a 1/2 month credit (less any use). Cards cancelled after the 15th of the month will not be credited.</p> <p>I certify that I have read, understand and accept the conditions specified in this application.
